
Dear Sirs:

AGREED FINAL JUDGMENT OF CORPORATE DISSOLUTION

THIS MATTER coming on before the Court and it appearing to the Court that the parties hereto have stipulated and agreed that La Chucua Paso Fino Horse Farm, Inc. and La Chucua Land Company, Inc. should be dissolved and through the Court's authority under §607.1433, Florida Statutes in the manner following and the Court being otherwise duly advised in the premises, it is therefore

ORDERED AND ADJUDGED that:

1. La Chucua Paso Fino Horse Farm, Inc., a Florida corporation, is hereby dissolved effective December 11, 1995.
2. La Chucua Land Company, Inc., a Florida corporation, is hereby dissolved effective December 11, 1995.
3. Pursuant to Section 607.1432, Florida Statutes, Ms. Terri Kitchens continues in her capacity as Receiver and is appointed to wind up and liquidate and manage the business and affairs of each of the corporations as provided in the Order

Appointing Receiver entered October 27, 1995 and incorporated here.

4. The Receiver is directed to wind up and liquidate in accordance with Section 607.1405, Florida Statutes and to notify claimants in accordance with Section 607.1406, Florida Statutes.

5. The Court retains jurisdiction to amend the Order Appointing Receiver and to enter other orders necessary to enforce this judgment.
