ARTICLE ONE


The name of the corporation is COPY PRODUCTS COMPANY OF PANAMA CITY.

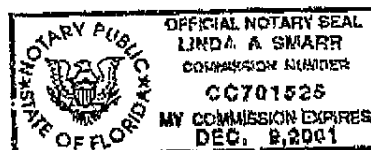
