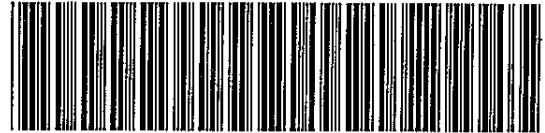

WHEREAS, the undersigned is the sole stockholder, director and officer of the Florida corporation known as INTER-CONTINENTAL TRADING, INC.

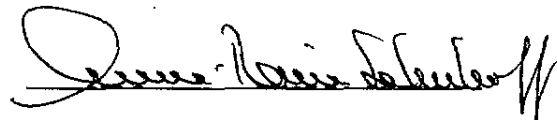
WHEREAS, the Articles of Incorporation of INTER-CONTINENTAL TRADING, INC. reserves the right to amend the Articles of Incorporation.
