First: Document #P94000023482 to change name from D.T.C. Sales, Inc. to D.T.C. Sales, PA. The nature of the business is Real Estate Sales.

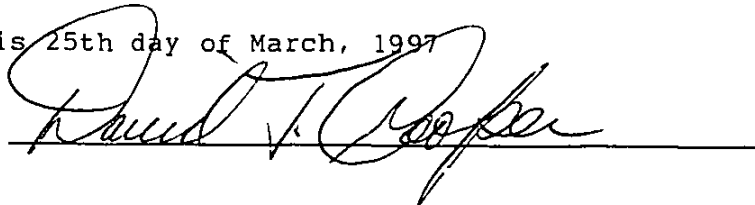
