2. *Phylogenetic relationships*—The phylogenetic relationships among the 12 species were determined using the maximum parsimony method. The analysis was performed using the program PAUP 4.0 (Swofford, 1999). The heuristic search was performed using 1000 random starting trees. The tree was collapsed using the parsimony criterion. The support for the nodes was determined using the bootstrap method (1000 replicates). The tree was rooted using *Phragmites australis* as the outgroup. The tree was drawn using the program TreeView 1.6.6 (Rambaut, 1999).
