To Whom It May Concern:

I am enclosing our check in the amount of \$300.00 to cover the two years we missed sending in our Corporate Fees: 2004 and 2005. I am also enclosing our Corporate Reinstatement form that I downloaded from your Internet site. I called asking for abatement of the late penalties and was advised to send \$300 with this letter asking for abatement.
