ARTICLES OF AMENDMENT TO ARTICLES OF INCORPORATION OF <u>MEI OF FLORIDA, INC.</u>



Pursuant to the provisions of Section 607.1006 of the Florida Business Corporation Act (the "Act"), the undersigned corporation adopts the following Articles of Amendment to its Articles of Incorporation:

- 1. The name of the Corporation is MEI OF FLORIDA, INC. (the "Corporation"), Charter #P94000024989, filed on March 28, 1994.
- 2. The Articles of Incorporation of this Corporation are amended by changing the Article numbered I, so that, as amended, said Article shall read as follows:

ARTICLE I
