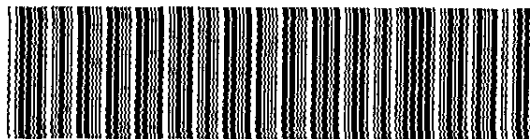

**'ARTICLE I - NAME**


The name of this corporation shall be:
