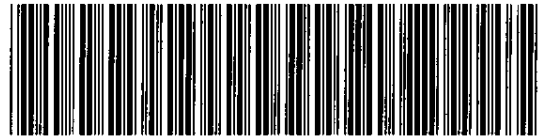

1. The following provisions of the Articles of Incorporation of Wiesner Associates Chartered, a Florida corporation, are amended in the following particulars:


Article I is hereby amended to read as follows:


