ARTICLES OF AMENDMENT TO ARTICLES OF INCORPORATION OF MULTITECH BROKERAGE SOLUTIONS, INC.

INC., a Florida corporation (the "Corporation"), does hereby certify that the Amendment provided for herein to amend Article V to the Corporation's Articles of Incorporation was adopted by resolution at a regularly scheduled and noticed meeting of the Board of Directors of the Corporation held on December 18, 1997 and that the holders of a majority of the outstanding shares of the Corporation's Common Stock entitled to vote approved this Amendment by a Special Corporate Action by Written Consent of Shareholders such that the number of votes cast for the amendment was sufficient for approval by the shareholders. - The total number of shares of stock authorized to be issued by the Corporation shall be 10,000,000 shares having a par value of \$.001. Each of the said shares of stock shall entitle the holder thereof to one (1) vote at any meeting of the stockholders.
- In the election of directors of this corporation there shall be no cumulative voting of the stock entitle to vote at such election."

All other provisions of the Articles of Incorporation remain the same as originally filed.
