ARTICLES OF AMENDMENT  
OF THE  
ARTICLES OF INCORPORATION OF  
**BRICKLEMYER SMOLKER & BOLVES, P.A.**

Bricklemyer Smolker & Bolves, P.A., a Florida corporation (the "Corporation"), in order to amend its Articles of Incorporation in accordance with the requirements of Section 607.1001 et. seq. of the Florida Business Corporation Act of the State of Florida, does hereby certify as follows:

1. The current name of this Corporation is **Bricklemyer Smolker & Bolves, P.A.**
2. The Articles of Incorporation of the Corporation were filed with the Secretary of State of the State of Florida on April 8, 1994.
3. The amendment to the Articles of Incorporation being effected hereby will completely delete the first Article thereof and substitute in its place the Article set forth below.
4. As amended below, the first Article of the Articles of Incorporation has the sole effect of changing the Corporation's name from "Bricklemyer Smolker & Bolves, P.A. to "Bricklemyer & Associates, P.A."
5. The proposed amendment to the Articles of Incorporation was recommended to the shareholders by the unanimous written consent of the Board of Directors on December 16, 1998. Unanimous approval by the shareholders of this Amendment was obtained on December 16, 1998 as required by Florida law.
