
The above-referenced corporation was administratively dissolved in September, 1997. It has only recently come to the attention of Dennis Grass, the principal of the corporation, that this occurred. According to Mr. Grass a man employed by the corporation as a CPA, but who turned out merely to be a bookkeeper, failed to fulfill his duties and obligations that he had assumed for the corporation, which duties included making the proper payments and filings to keep the corporation active with your office.

Therefore, we are respectfully requesting that you allow a waiver of any reinstatement penalties which may apply. Mr. Grass and his said company have suffered considerable damage and expense as a result of the said "CPA's" misfeasance (and possible malfeasance). If your office can give this company a break, it would be very meaningful, because the funds enclosed are borrowed funds.

In this regard, provided herewith please find an original Corporation Reinstatement Form for the above-referenced entity, along with check number-0102 in the amount of \$617.50. The enclosed check is intended to represent payment of the Annual Report fee in the amount of \$150.00 for each of the years, 1997, 1998, 1999, and 2000, along with \$8.75 for a certified copy of the Articles of Incorporation, and \$8.75 for a Certificate of Status following reinstatement. We would appreciate the full reinstatement of the corporation as soon as reasonably possible.

Thank you for your attention and assistance in this regard. We look forward to receiving confirmation of reinstatement, a Certificate of Status, and a certified copy of the Articles of Incorporation.
