IN WITNESS WHEREOF, the undersigned has executed these Articles of Dissolution this 20th day of January, 1998.



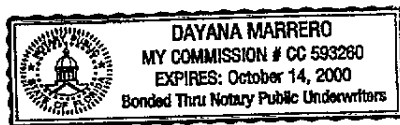
