TO

Pursuant to the provision of Section 607.1006, Florida Statutes, the undersigned corporation adopts the following amendment to its Articles of Incorporation:

1. The name of the corporation is **DAVIS HIGHWAY MOTEL, INC.** (the "Corporation").
2. The Corporation's Articles of Incorporation (the "Articles") were first filed with the Secretary of State of the State of Florida on April 7, 1994.
3. Article Six of the Articles is deleted in its entirety and replaced as follows:
