ARTICLES OF AMENDMENT TO ARTICLES OF INCORPORATION


OF

Suncoast Health Magazine, Inc.

1. Article I of the Articles of Incorporation of Suncoast Health Magazine, Inc., a Florida Corporation (which Articles were originally filed on April 11, 1994, when the Corporation's name was McEwan - Campbell Publishing Company, and an amendment to which was subsequently filed on May 31, 1994, changing the Corporation's name to Suncoast Health Magazine, Inc.) is hereby amended to change the name of the Corporation to "EdLyn Associates Corporation," and the old corporate name shall be replaced with the new name throughout the Articles of Incorporation of this Corporation.

2. The foregoing Amendment was adopted by unanimous vote of the Stockholders and Directors of the Corporation on December 9, 1997.


