**ARTICLES OF AMENDMENT
TO
ARTICLES OF INCORPORATION
OF
ISG PRODUCTIONS, INC.**

ISG PRODUCTIONS, INC., a Florida corporation (the "Corporation"), hereby adopts an amendment to its Articles of Incorporation as hereinafter set forth.

1. Pursuant to Section 607.1003 of the Florida Statutes, a majority of the shareholders of the Corporation adopted, in accordance with Section 607.0704 of the Florida Statutes, on June 12, 1997, an amendment to Article I of the Articles of Incorporation of the Corporation deleting said Article I in its entirety and substituting therefor the following:
