## ARTICLES OF AMENDMENT TO ARTICLES OF INCORPORATION OF SATELINK SYSTEMS CORP.

- 1. The name of the corporation is SateLink Systems Corp. (the "Corporation").
- 2. Article III of the Articles of Incorporation of the Corporation is hereby amended in its entirety to read as follows:

## "ARTICLE III - CAPITAL STOCK

The corporation is authorized to issue 1000 shares of common stock having a par value of One Dollar (\$1.00) per share, which shares shall be and hereby are designated as "Common Shares".
