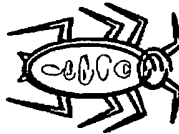
Pursuant to the provisions of section 607.1006, Florida Statutes, the Florida profit corporation adopts the following article of amendment to its articles of incorporation:

Eighth: Amendment amended: VI Change the name and address of the Chairman to Richard A. Macaluso 4847 Basswood Land O'Lakes, FL 34639.

Ninth: Amendment amended: VII Change the name and address of the President and the Secretary-Treasurer to Richard A. Macaluso 4847 Basswood Land O'Lakes, FL 34639.

Tenth: Amendment amended: XII Acknowledge that the Service Mark, both logo and name has been approved by the State of Florida and are owned by Jimmy R. Haws. Use of the name and logo by this Corporation will continue and unless Jimmy R. Haws has majority shares in the Corporation, then the Corporation will pay \$1,000 monthly for its use beginning August 1, 1997. Admen to clarify the Service Mark that the corporation officially adopts. The service mark, artistic rendered insect, which has been used since January 2, 1993 and is the service mark of the corporation.

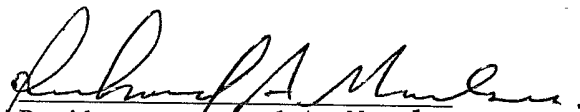
