To Whom It May Concern;

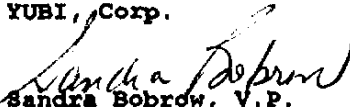
It has come to our attention that we have not received an "Annual Report" form for 1998. We have enclosed a copy of the 1997 form indicating a February 1997 payment date.
