Per my discussions with your offices, which subsequently instructed me to provide the following information, after receipt of replacement '2000 Uniform Business Report Form' mailed by your offices to our new address and received about August 24, 2000.

As instructed we are providing the following information.

Upon moving from our original address of 33 Northeast 2nd Street, Fort Lauderdale, Florida we notified the U.S. Post Office of our new forwarding address which was 719 East Las Olas Boulevard, 2nd Floor Rear Suite, Fort Lauderdale, Florida 33301.

Within a short period of time, we noted that we were not receiving the usual mail and had been advised by numerous clients that we were not receiving our mail.

On November 12, 1999 we filed a formal complaint with the post office and they agreed to investigate.

U.S. Post Office Complaint No. DE4073225

It was found that the post office had been delivering our mail to an empty office in the front of our building and when new tenants began occupying that office some employees of that office would return our mail.

After numerous calls and complaints it was further discovered that the postal carrier was not consistent and the mail continued to be delivered to the wrong address and/or returned by the postal carrier.

On January 25, 2000 a further complaint was filed with the post office and they agreed to investigate.
