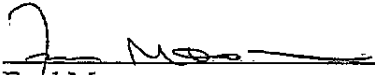
1. The name of the Corporation is Central Florida Safe & Lock ESD, Inc.

**ARTICLE I – NAME OF CORPORATION**

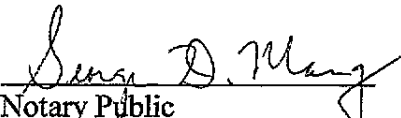
The name of the Corporation shall be Precision Fire and Security, Inc.
