2. The Corporation was formed in the State of Florida on April 25, 1994, under Charter No. P94000031080.

3. The Board of Directors of the Corporation proposed dissolution of the Corporation to the Shareholders of the Corporation, and a majority of the Shareholders approved such dissolution in accordance with Section 607.1402 of the Florida Business Corporation Act and such majority vote of the Shareholders was sufficient for approval. on May 2, 1999


