- 1. The name of the corporation is MUBEEN H. CHIDA, M.D., P.A.
- 2. The following amendment of the Articles of Incorporation was adopted by the shareholders and directors of the corporation on June 15, 1998, in the manner prescribed by the Florida General Corporation Act:
