I am writing to request special dispensation for the penalty being imposed for failure to file the 1998 Profit Corporation Annual Report within the designated time allowed.

I received the 2<sup>nd</sup> notification on 7/3/98. I never received the first notification that this Annual fee was due. The mitigating circumstances are as follows:

- Since incorporation I have been using the same accounting firm in Orlando, Florida. Each spring at tax time, I would sit down with my accountant, he would tell me to write checks in varying amounts as needed to satisfy all required filings and to pay taxes.
- Last September through November I was in the process of moving my residence and corporation to my new address in Ft. McCoy, Florida. Although there was a forward on my mail, I never received any notification of this filing.
- 3. My accountant prepared my taxes this year via telephone and fax, and never advised that this Filing Fee was due.
- I received this second notification with a penalty of \$400.00 due in addition to the normal filing fee.
- 5. I called the Customer Service number listed on the enclosed form, and was advised that I could pay the regular fee, and send you a letter requesting that the penalty be waived.

Therefore, I have enclosed the Annual Filing Fee of \$61.25 for the Annual Report and \$88.75 for the Corporation Supplemental Fee, a total of \$150.00. It is my understanding that if this is not satisfactory with your office you will notify me in time to pay the penalty prior to September 30, 1998 so that my corporation will not be dissolved.

I realize that ignorance of the required filing is not a viable excuse, but that is my only defense. Now that I am aware of this requirement, all future filings will be in a timely fashion.
