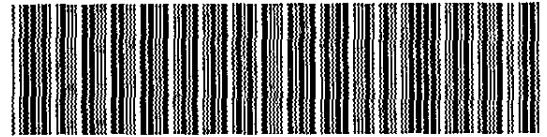

Article I - Name be and it hereby is amended to read as follows: "The name of this Corporation is Real Estate Professionals Realty, Inc."

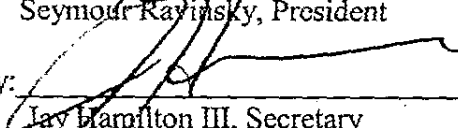
2. The foregoing amendments were adopted by the Stockholders and Directors of the corporation on the 24 day of September, 2003.
