
In connection with the reinstatement of the above corporation, we have enclosed an application for Corporation Reinstatement for S & S Marketing, Inc., including the name and address of the Registered Agent.

As my assistant discussed with your office, S & S Marketing, Inc. moved their business office and did not receive notice of the 2003 Annual Report/Uniform Business Report or subsequent Annual Report/Uniform Business Reports for years 2004 and 2005. Therefore, the Corporation was not able to file the Reports for the years 2003 through 2005 in a timely manner, which resulted in the administrative dissolution of the Corporation. In addition, we have discovered that the name "S & S Marketing, Inc." is now being used by a different party and no longer available. Therefore, we have also enclosed two signed originals of the First Amendment to the Articles of Incorporation to provide for the name change to S & S Marketing of Central Florida, Inc.

We have enclosed a check in the amount of \$485.00 made payable to Department of State to cover the reinstatement fees of \$450.00 and the \$35.00 fee for the filing of the First Amendment to the Articles of Incorporation.
