Dear Sir or Madam:

I am attaching this letter to the filing by the aforementioned taxpayer of their 1999 Corporation Annual Report as per instructions received by your office. The taxpayer is filing their Annual Report with a fee of \$ 150.00 even though it is being filed after May 1, 1999.

I phoned your office to verify that a postmark of September 15, 1999 would suffice to prohibit an involuntary dissolution. I explained that this filing was being prepared by that date on report forms which indicated a filing fee of \$ 550.00, instead of the normal \$ 150.00. The taxpayer files did not disclose an Annual Report form for the original filing requirement of May 1, 1999. Since the taxpayer could not verify receipt of the original return, which should have been received earlier in the year, your office advised me to have the taxpayer file with the forms enclosed with the original fee of \$ 150.00, and that your office would accept that as timely, and not expose the taxpayer to any late fees or penalties.
