We are in receipt of your Letter Number: 203A000373311 dated June 17, 2003 stating that our 2003 Form UBR is considered late and that a late fee of \$400 is being assessed.


Please be advised that we are a traveling business, currently in Michigan, and for that reason mail is delayed in reaching us. Our business is quite intricate and is comprised of quite a few corporations and partnerships. As a result, it takes many months after the end of our tax year to compile all pertinent information for all entities involved so that our accountants can properly and accurately complete and file all the required state and Federal returns for our business.

It is because of this that our accountants secure extensions of time to file for all returns required by state and Federal laws. When we sent you our Form UBR, we attached a copy of Form 7004 (Application for Automatic Extension of Time To File Corporation Income Tax Return). We are of the belief, and so are our accountants, that the application for a Federal extension automatically covers the related state returns. Hence, our late filing was not an intentional nor negligent act, but rather based on our interpretation of the applicable rules.

Based on the above, we respectfully request that the late filing penalty assessed be abated and that the subject return be deemed timely filed. We will be making a similar request for other entities, as we strongly feel that a penalty of almost 300% is unreasonable when intention and negligence are not present. We were merely attempting to properly comply with our corporate and business obligations under all state and Federal laws and do not feel being penalized such an exorbitant amount would be appropriate in this instance.

Thank you in advance for your consideration in this matter. We are also enclosing our original filing for your acceptance.
