1. The name of the corporation is Coastline Plastics, Inc.
2. Article I of the Articles of Incorporation of Coastline Plastics, Inc., a Florida corporation, is hereby amended in its entirety to read as follows:

The name of this corporation is:

Yulee Plastics, Inc.

3. The foregoing amendment was recommended by the members of the Board of Directors of the corporation and was adopted on October 13, 1998 by unanimous written consent by the shareholders of the corporation entitled to vote, pursuant to Section 607.1003, Florida Statutes (1997). The number of votes cast for the amendment by the holders of the voting common stock of the corporation, the only voting group entitled to vote on the amendment, was sufficient for the approval of the amendment.

4. The foregoing amendment shall become effective upon the date of filing of these Articles of Amendment with the Secretary of State of the state of Florida.
