Enclosed you will find the completed Uniform Business Reports for my existing corporations. Due to extenuating circumstances, these reports are being filed late. I had my new bookkeeper telephone your office regarding the possibility of waiving the late fees I have incurred. Your people instructed her to have me send along a letter of explanation for your consideration in making your decision regarding this matter.
