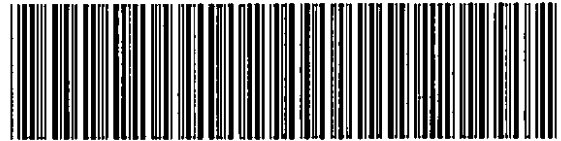

ARTICLE III


The dissolution was authorized on July 26, 2018. The effective date of the dissolution is August 1, 2018.

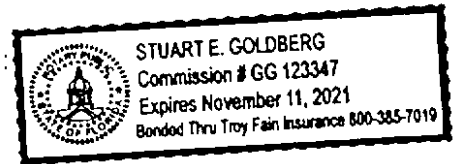


