On January 30, 1998, I called the Division of Corporations to check on the status of Homeland Construction Company, Inc. At that time I was told that the Corporation had been dissolved. I had reinstated the corporation in 1996, but never received any conformation - other than a phone call I made and was told it had been reinstated. On this reinstatement, I had changed the address, which is what caused the problem in the first place. Once again the Annual Report was mailed to an incorrect address. Since I did not receive the Annual Report, it was not filed, and the Corporation was again dissolved without our knowledge.
