ARTICLES OF AMENDMENT TO THE ARTICLES  
OF INCORPORATION OF

Pursuant to the provisions of Section 607.1006 of the Florida General Corporation Act, the undersigned corporation adopts the following Articles of Amendment to its Articles of Incorporation:

1. Article IV is hereby restated as follows:

ARTICLE IV  
AUTHORIZED STOCK

This Corporation is authorized to issue Ten Thousand (10,000) shares of One Dollar (\$1.00) par value, common stock.

The shares of this Corporation are not to be divided into classes.

This Corporation is not authorized to issue shares in series.

2. The foregoing Amendment was adopted by the unanimous consent of all of the Shareholders of the Corporation on the 30th day of March, 1998, in the manner prescribed by the Florida General Corporation Act.
