BRONX, N.Y. (AP) — The New York City Police Department said it has arrested a man suspected of being involved in the shooting of a police officer in the Bronx last month. The officer was shot in the back of the head while on patrol in the 100th Precinct, which covers the area around the Bronx Zoo. The suspect, a 34-year-old man, was arrested on Monday and charged with second-degree murder and carrying a dangerous weapon. The police department said the suspect was seen running away from the scene of the shooting, which occurred on Sunday. The officer was taken to a hospital and is expected to survive. The police department is still looking for other suspects in the case.
