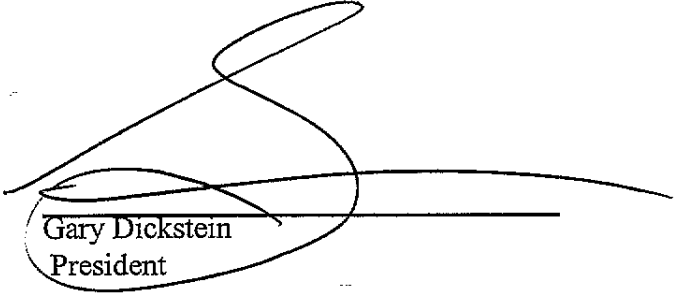
1. The name of the Corporation is Dickstein, Reynolds, Woods & Murasko, P.A.
