This is to respectfully request that you waive the \$400 late filing fee for the Uniform Business Report for the referenced entity due to the following reason:

Cathy Sue Weaver, the sole officer/director of this corporation, was murdered on August 27, 2001, and the killer set fire to her residence, which was also her place of business. Since she was the sole employee of this business, active operation of the company ceased as of the date of her death. A copy of her death certificate is attached for your records.

I was appointed Personal Representative of Ms. Weaver's estate by her family. As such, I hired the accountants she had previously employed to prepare the remaining accounting and tax filings for the business. I did not become aware until I met with the accountants yesterday regarding the year 2001 business income tax return that the Uniform Business Report was in the past prepared by Ms. Weaver personally, and consequently was not prepared for the current year by the accountants. I also was under the erroneous impression that the report was not due for the current year, because the business had ceased operations in 2001. Unfortunately, however, certain issues that have not yet been resolved will require that the corporation file another - final - tax return for 2002. The accountants have explained that this makes it necessary for the corporation to file the Uniform Business Report for 2002 as well, in order to avoid premature dissolution.


