Figure 6 shows the results of the regression analysis. The model explains 70% of the variance in the dependent variable ($R^2 = .70$). The adjusted R^2 value is .68. The F-statistic is 19.84, which is significant at the .001 level. The t-statistics for the coefficients are also significant at the .001 level.
