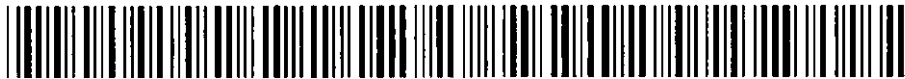

ARTICLE VI


The effective date of the Corporation's voluntary dissolution with the Florida Department of State Division of Corporations shall be December 31, 2022.

3. The harm suffered by claimant.


