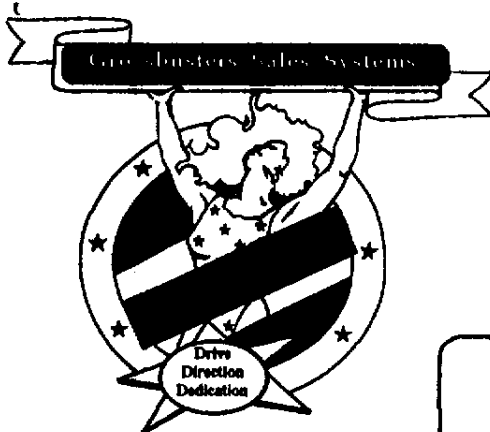

To whom it may concern,

This is in reference to FEI # 65-0494038 North Star Lady, Inc. It just came to my attention that my corporation was dissolved by your office in the summer of 1996 due to non filing of annual reports, which I was unaware of.

I was applying for a job contract for my company when the client handed me a "public records on line" report showing my company was dissolved in 1996. Much to my embarrassment, they agreed to hire me as long as this was taken care of, which is what I am trying to do now. ( I have enclosed the information).

I noticed that the address you show for my company was 1975 E. Sunrise Boulevard, #820 5th Floor, Ft. Lauderdale, FL 33304 and 2400 E. Commercial Blvd #808 Ft. Lauderdale, FL 33308. I guess the reason I didn't receive the reports is because I went through a really terrible divorce in 1995 and lost my business offices and most of my records were also tied up due to the fact that I was in business with my former husband. The mail must have been transferred from Sunrise over to Commercial Blvd. which is his office and they must of thrown them away. I have been working diligently to clean up my financial disaster - and because he got the company, I was forced to find a new career after 15 years in business with him. I have two children to support and have spent the last 2 years struggling to clear up my tax debts, and my credit is ruined. This job is very important to me and will give me the chance to start a new career, so I have to get this corporation reinstated as soon as possible.

I am asking you to please waive the penalties to reinstate my corporation, because I just can't afford to get this done with all these penalties. I am sending you the \$200 fee for 1996, \$165 for 1997 and \$150 for 1998 which is a total of \$515 and is all I can afford.
