**ARTICLES OF AMENDMENT  
TO THE ARTICLES OF INCORPORATION  
OF  
GARY W. COATOAM, D.D.S., M.S., P.A.**

Pursuant to the provisions of Sections 607.1003 and 607.1006 of the Florida Statutes, **GARY W. COATOAM, D.D.S., M.S., P.A.**, adopts the following Articles of Amendment to its Articles of Incorporation:

1. The name of the corporation is **GARY W. COATOAM, D.D.S., M.S., P.A.**
2. The original Articles of Incorporation for the corporation were filed on June 7, 1994, and assigned Charter No. P94000042260.
3. By written consents executed on January 3, 2003, by all of the shareholders and all of the directors of the corporation, respectively, the shareholders and directors have approved, authorized and directed that the Articles of Incorporation shall be amended to change the name of the corporation to "**COATOAM & KRIEGER, P.A.**"
4. Article 1 of the Articles of Incorporation is hereby amended to read as follows:

**ARTICLE I - NAME**

The name of this corporation shall be **COATOAM & KRIEGER, P.A.**
