**ARTICLES OF AMENDMENT TO THE ARTICLES OF INCORPORATION OF
FLORIDA HEALTH PROFESSIONALS, P.A.**

The corporation whose Articles of Incorporation are amended by these Articles of Amendment was incorporated pursuant to Chapter 621, Florida Statutes, under the name FLORIDA HEALTH PROFESSIONALS, P.A., on June 9, 1994.

Pursuant to the provisions of Section 607.1006, Florida Statutes, the Articles of Amendment to the Articles of Incorporation of FLORIDA HEALTH PROFESSIONALS, P.A., (the "Corporation") are as follows:

1. The name of the Corporation is FLORIDA HEALTH PROFESSIONALS, P.A.
2. The Articles of Amendment to the Articles of Incorporation were adopted by all the directors and all of the shareholders of the Corporation on October 15, 1998 in the manner prescribed by Section 607.1003, Florida Statutes, as follows:

RESOLVED, that Articles I and II of the Articles of Incorporation of FLORIDA HEALTH PROFESSIONALS, P.A., are hereby authorized to be amended in their entirety to read as follows;

ARTICLE I

NAME OF CORPORATION

1. The name of the corporation shall be FLORIDA HEALTH PROFESSIONALS, INC., (the "Corporation").

ARTICLE II

NATURE OF BUSINESS

2. The Corporation is organized for the purpose of transacting any and all lawful business for corporations organized under The Florida Business Corporation Act of the State of Florida.
