14. I, however, would not submit that the defendant required both the things, completely furnished and those not supplied, for the satisfaction claimed as his own. I am satisfied, therefore, that the defendant was entitled to the amount of the agreed-upon amount paid for the things supplied and that my judgment shall be for the same against the defendant and in favor of the plaintiff. Wherefore, I do hereby recommend that the defendant be ordered to pay the amount of the agreed-upon amount to the plaintiff, and that the plaintiff be ordered to deliver the things supplied and that the plaintiff be ordered to pay the amount of the agreed-upon amount to the defendant.
