

ARTICLES OF AMENDMENT TO THE ARTICLES OF INCORPORATION OF INNOVATION TECHNOLOGIES, INC.

Pursuant to the provisions in Section 607.1006 of the Florida Statutes, the undersigned corporation hereby adopts the following Articles of Amendment to its Articles of Incorporation pursuant to a meeting of the shareholders of the Corporation duly called on May 18, 2012:

1. The following amendment to the Articles of Incorporation of Innovation Technologies, Inc. was adopted by holders of a majority of the outstanding shares of the common stock of the corporation on May 18, 2012, in the manner prescribed by the Florida General Corporation Act:

ARTICLE IV-CAPITAL STOCK
