

WHEREAS, CROWDER GREENLAND, INC. was incorporated effective as of June 16, 1994, with its principle place of business at P. O. Box 746, Niceville, Florida 32588;

WHEREAS, the purposes for which CROWDER GREENLAND, INC. were founded no longer exist as a business opportunity;

WHEREAS, all the debts of the corporation have been satisfied and the remaining assets distributed; and

WHEREAS, that after proper notice and the unanimous vote of the shareholders, it was approved to dissolve the corporation.

1. That the preamble to these Articles of Dissolution are incorporated herein and by these Articles, CROWDER GREENLAND, INC., does, under the authority of Sec. 607.1403, Florida Statutes, hereby dissolve itself as a corporation registered with the State of Florida, with these Articles being a memorial of the action of the shareholders.

2. The effective date of dissolution is August 1, 1998.
