2. Check number 3072 in the amount of Seven Hundred Fifty Dollars (\$750.00).


Also enclosed is the above referenced letter per your request of November 20, 2000.

## ARTICLES OF REVOCATION OF DISSOLUTION


*Pursuant to §607.1404, Florida Statutes, the undersigned corporation hereby submits the following Articles of Revocation of Dissolution:*
