Dear Mr. Cauldwell:

Thank you for taking the time to speak with my husband, Frank Shaughnessy, this morning.

I honestly don't know what happened here. India, Inc. does business as Frontier Adjusters of Miami/Coral Gables/Homestead/Key West. I am the principal and work from my house. This is my first business and my first corporation. In June of 1995, we moved from 4890 NW 102 Ave., Apt. 103, Miami 33178 to the 7245 SW 112 St., Miami 33156 address. We have never received any correspondence from the Division of Corporations.

On March 5, 1996 we sent a copy of the enclosed letter seeking to amend our corporate status, please note our 112th St. address is on this letter. We are told there was a March 20, 1996 response from the Department that enclosed a form that was sent to the 112th St. We never received this response.

We are further told that the Department then sent a request for an Annual Report for 1996, and then a notice of pending dissolution and finally a dissolution notice -- but these last 3 notices were sent to the 102 Ave. address and not to the 112 St. address, which the Department had notice of from our March 5, 1996 letter.

To add to our problems our Registered Agent is myself, Vicki T. Shaughnessy, whose address is the same as the corporation's and in the Department's records, which in 1996, was the 102 Ave. address, which means we did not receive the benefit of our registered agent receiving the notice of pending dissolution.

We would argue that if the Department had updated their records as to our address upon the receipt of the March 5, 1996 letter from us, even though we did not receive the Department's March 20th letter, we probably would have received one of the Department's 3 following letters about the 1996 Annual Report or the pending dissolution notices. If we had, we would have filed the 1996

annual report and fee and avoided dissolution, at best. At worst, we would have reinstated in 1996 paying the annual fee and the reinstatement fee of \$175.00.

At this time we would ask that upon review, we would be allowed to pay the annual fees for 1996, 1997 and 1998 plus the "old" reinstatement fee of \$175.

Enclosed is our check in the amount of \$690.00 which encompasses the above, along with a check in the amount of 150.00 for the deletion of Frank J. Shaughnessy as an officer (which is what I have been trying to do since March of 1996 and has ultimately led to the discovery of the administrative dissolution. Interestingly, my January 27, 1998 filing of amendment which was returned February 3, 1998 by the Department for correction, makes no mention of the administrative dissoultion). The completed Annual Report form is also enclosed.

Additionally. I enclose copies of our 1996, 1997 and 1998 Florida Intangible Tax Returns for Corporations, which all show the 112 St. address. We have been operating under the impression that India, Inc. is fully functional and active. All our payments to both the Federal and State governments have been in the name of India, Inc. and have been made with the FEI number 65-0503161. Needless to say, representations to our clients, franchisor, insurance companies, etc. are all made in the name of India, Inc., dba Frontier Adjusters of Miami/Coral Gables/Homestead/Key West.

What I am trying to say is, we did not fail to make reportings to the Florida Department of State, Division of Corporations with any malice or even, intention. We simply neglected to make the proper filings because we did not receive any notification that our filings were due. I cannot say why I did not think an annual report would be due.

We apologize for the problems and inconvenience our lack of sophistication may have caused. Thank you for your kind consideration. Please let me know if I need to do anything else.
