

ARTICLES OF AMENDMENT TO ARTICLES OF INCORPORATION OF PREMIER CABLE COMMUNICATIONS INC.



Pursuant to the provisions of Section 607.1006 of the Florida Statutes, this Florida profit corporation hereby adopts the following Articles of Amendment to Articles of Incorporation:

FIRST: The name of the Corporation is PREMIER CABLE COMMUNICATIONS INC.

SECOND: The following amendment was unanimously recommended for shareholder approval by Consent in Lieu of Special Meeting of the Board of Directors of the Corporation on December 26, 2000, and was adopted and approved by Consent in Lieu of Special Meeting of the Sole Shareholder of the Corporation on December 26, 2000, in the manner prescribed by applicable law:
