ARTICLES OF AMENDMENT
TO
ARTICLES OF INCORPORATION
OF
NEW WORLD BREWING SYSTEMS, INC.

Article I of the Articles of Incorporation of New World Brewing Systems, Inc., a Florida corporation (the "*Company*" or the "*Corporation*"), is hereby amended to read in its entirety as follows:

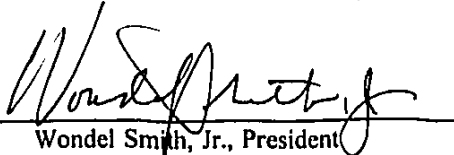
ARTICLE I - NAME

The name of the corporation shall be WS&JK, Inc. (hereinafter, the "*Corporation*" or the "*Company*").

The foregoing amendment was adopted by the written consent dated June 16, 1997 of the majority shareholder of the Company in accordance with Sections 607.0704 and 607.1003(6), *Florida Statutes*. The holders of the Common Shares of the Corporation were the only voting group entitled to vote on the amendment, and the number of votes cast for the adoption of the amendment by that voting group was sufficient for approval by that voting group.
