

**A RESOLUTION OF THE SHAREHOLDERS AND
DIRECTORS OF WRIGHTWAY TRANSPORTATION SERVICES,
INC. TO DISSOLVE THE CORPORATION; AND PROVIDING FOR
EFFECTIVE DATE.**

WHEREAS, the stock and controlling interest in Wrightway Transportation Services, Inc. was sold by Ian Wright, sole stockholder and President of the corporation, to 2 Entertainment Limousines, Inc. on January 20, 2003 pursuant to an Acquisition Agreement; and,

WHEREAS, the sole purpose of the sale of stock and specific assets of the corporation was to transfer the Certificate of Public Convenience and Necessity and two (2) Limousine Permits issued by the Hillsborough County Public Transportation Commission; and,

WHEREAS, the stockholder and officers of Wrightway Transportation Services Inc. believe that it would be in the best interest of the stockholder, officers and directors to dissolve Wrightway Transportation Services, Inc; and by majority vote at a meeting held on March 21, 2003, directed that the State of Florida, Division of Corporations and any known creditors be so advised.


