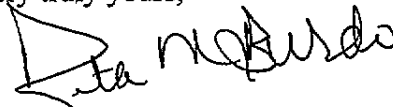

**ARTICLES OF AMENDMENT TO  
ARTICLES OF INCORPORATION OF  
JUPITER SPINAL HEALTH CENTER, INC.**

Pursuant to the provisions of sections 607.1805 and 607.1006, Florida Statutes, JUPITER SPINAL HEALTH CENTER, INC. adopts the following Articles of Amendment to its Articles of Incorporation:

**FIRST:** The name of the corporation is JUPITER SPINAL HEALTH CENTER, INC. (the "Corporation").

**SECOND:** Article I of the Articles of Incorporation of the Corporation is amended in its entirety to read as follows:

"Article I

The Corporation is organized solely for the purpose of the practice of chiropractic medicine. The name of the Corporation is JUPITER SPINAL HEALTH CENTER, P.A."

**THIRD:** It is the intent of these Articles of Amendment for the Corporation to terminate its status as a corporation under Chapter 607 of the Florida Statutes, as amended, and to continue its existence as a professional service corporation under Chapter 621 of the Florida Statutes, as amended.

**FOURTH:** The Amendment was recommended by the Board of Directors to the Corporation's shareholder on May 6, 1998.

**FIFTH:** This Amendment was approved and adopted by the sole shareholder of the Corporation on May 6, 1998.
